UNITED MARTIAL ARTS CENTERS CONDITIONS OF REGISTRATION

The Parent/Guardian warrants and represents the camper is in sound physical and mental health and fully able to participate in all camp activities without need of individual or specialized attention or medical regimen and the camper's health will not impinge or impact negatively on other campers or the camp program. This includes any allergies, physical conditions, mobility issues, etc., which may require special attention and, if so, please attach a separate sheet of paper and specify the nature of such condition and the necessary treatment or accommodations. Parent further agrees to advise camp promptly of any change in the camper's physical or mental health between the date of enrollment and start of the camp season.

"I understand that part of the camping experience involves activities and group arrangements and interactions that may be new to my child, and that they come with certain risks and uncertainties beyond what my child may be used to dealing with. I am aware of these risks, and I am assuming them on behalf of my child. I realize that no environment is risk-free, and so I have instructed my child on the importance of abiding by the camp's rules, and my child and I both agree that he or she is familiar with these rules and will obey them."

Parent will advise in writing (below) of his/her camper's history of medical conditions or surgical procedures, therapy programs and or regularly-taken prescriptions medications or special needs: PLEASE BE SPECIFIC.

At any time before opening day or during the camp season United Martial Arts Centers retains the right to cancel this contract if it determines that the physical, mental, medical or emotional condition of the child would prevent him/her from participating safely and satisfactorily in our program or interacting positively with other campers. Also, once United Martial Arts Centers is in session, UMAC can initiate the cancellation of this contract and the dismissal of the child if the child exhibits unacceptable behavior which prevents our staff from safely supervising him/her or proves detrimental to himself/herself, other campers or staff members as determined by UMAC directors.

The parent who signs this registration form represents that he/she has full authority to do so and will be responsible for payment of the camp fees. No refund will be made for early withdrawal of the child before the end of the camp season.

It is agreed that any dispute or cause of action between the parties, whether out of this agreement or otherwise, can only be brought in a court of competent jurisdiction located in Westchester County, N.Y. and shall be construed in accordance with the laws of New York.

United Martial Arts Centers will release your child to either parent (or persons authorized by same) on our site at any time during the day if parental arrangements for pick up have been made beforehand with the camp office. If both parents do not live at the same address, the above procedure will apply unless restricted by a court order. Absent same, disputes between parents must be resolved immediately or United Martial Arts Centers reserves the right to terminate this contract and dismiss the child. Should this action be required, no refund will be made.

The parent irrevocably authorizes and consents to the Camp's use of the child's name, photograph, portrait or image in connection with the Camp's brochure or other promotional or advertising publications and to the Camp's use of a child's and/or child's family's home address and phone number for group and car pool lists. The parents release the camp and shall indemnify and hold the camp harmless from and against any and all claims, liabilities and expenses (including reasonable attorney's fees arising from such use)

Policies for Summer Camp

1. Let us know verbally, about any medical conditions and/or allergies your child may have in addition to the forms you have filled out.
2. Be aware, if students require medication during camp hours, we must have a form from their doctor, allowing us to administer the medication.
3. Should your child become ill, the following guidelines should be adhered to:
 - a. Any child with a fever will not be allowed to attend camp that day and will be sent home.
 - b. Your child must be fever FREE for 24 hours before returning to camp.
 - c. Any child experiencing stomach illness will not be allowed to attend camp that day.
 - d. 24 hours must pass before the student will be allowed to attend camp again after vomiting.
 - e. You must let us know ASAP if your child comes down with any highly contagious disease (i.e. chicken pox) as we will be required to inform other campers.
4. If your child will not be attending camp, or will be leaving early/arriving late, please let us know as soon as possible. On field trip days we cannot wait for a child who will be late or not attending.
 - a. **Every Tuesday we will be leaving UMAC by 9:30 am to go to Splash Down Water Park.** Because of the length of the day, if you are not able to arrive before 9:30 am, you will unfortunately miss the day of summer camp.
 - b. If we are out on a field trip, we have specific plans as to when we will be departing and arriving to UMAC. If you need your child, and we are on a field trip, you are more than welcome upon calling our Director, to pick your child at the field trip location.
5. If someone other than those listed on the Summer Camp form will be picking your child, we will need a written notice from you. NO exceptions. Proper identification will be required before your child can be released.
6. All campers must have their UMAC Summer Camp shirt on field trip days. Any camper that comes on a field trip day without a shirt will be required to purchase a new one.
7. Children are not permitted to be barefooted outside of the Tae Kwon Do School
8. All paperwork must be received before the first day of camp. No camper may be brought to camp without completed paperwork (Emergency Contact Sheet and Immunizations).

Our Summer Program is accredited by the New York State Office of Family Services and we must adhere to their rules without exception. Any use of the word "camp" in this document refers to "program" under the regulations of the New York State Office of Family Services.

Every Tuesday is our Field Trip to Splash Down Water Park. Please have your child already prepared with sun block, towel, summer camp shirt & lunch.

CAMPERS ARE NOT ALLOWED ACCESS TO THEIR CELLPHONES DURING CAMP HOURS. If you need to reach your camper during camp hours, either the Camp Director or Asst. Director will be reachable during camp trips via cell phone.

2. Please include an ice pack to keep cold
3. Snacks, water, drinks can be purchased from our vending machine or brought by the student.
4. Students will have reading time daily; they must have a book to read or summer home work
5. Students must have clean uniforms daily
6. Drop off is 7:30 - 9:30 am and pick up is 4:45 - 6:00pm
7. Copies of up-to-date Immunizations must be presented prior to beginning the Program

We are continuing our efforts to make our Martial Arts Adventure Camp better every year. This year we plan on continuing these efforts. All campers will be assigned a counselor and senior camper. They are charged with the task of paying particular attention to each camper in their group in order to enhance each camper's individual experience. This also gives you a direct person to contact about any particular information. You will receive a letter from your children's counselor prior to camp and at the conclusion of each week of camp. You will be informed of activities and progress made by your child. End of summer session gratitude is appreciated to these counselors for their extra time and attention.

UMAC Adventure Summer Camp Weekly Activities:

Mondays: We focus on the theme of the week and we will incorporate indoor and outdoor activities, arts and crafts, martial arts fitness, weapons and curriculum based classes.

Tuesdays: Is our field trip to **Splash Down Beach and Water Park.**

Wednesdays: We focus on the theme of the week and we will incorporate indoor and outdoor activities, arts and crafts, martial arts fitness, weapons and curriculum based classes.

Thursdays: Hiking on various hikes throughout the region and outdoor activities such as kite flying, outdoor sports, etc.

Fridays: Water Wars and Parent Presentations - when we go outside and use our parking lot with super soakers (supplied by you) and hook up the hose! At 4:45pm we will have the children put on a martial arts performance for all the parents.

All of this while receiving daily top notch Martial Arts training by a professional trained Black Belt Martial Arts staff. We will be closed Tuesday July 4th for Independence Day.

We have a lot of activities planned for this summer, below is a short reminder list to help keep our child safe and happy this summer. Splash Down Beach & Water Park is every Tuesday on the condition that the weather is at least 80 degrees and no threat of rain.

Snacks and Lunches - Please provide your child with 2 snacks, lunch and plenty of drinks. If a child does not have a lunch parents will be called and required to bring in an appropriate lunch. As always peanuts and peanut products are not allowed at any time.

Camp Shirts - Students must bring their camp shirts Tuesday-Friday on camp days, with no exception. If a student does not come to camp with the appropriate shirt one will be provided, at your cost (\$20.00). Due to camp safety regulations there is **NO EXCEPTION CAMPERS MUST HAVE CAMP SHIRT ON TRIPS.**

Sunscreen - Please pack a bottle of sunscreen in your child's bag on days we will be going outside (Tuesday-Friday). We will have students apply sunscreen throughout the day as needed. For younger students needing help applying sunscreen please pack a **NO RUB SPRAY** so that counselors can assist them.

Camp Bags - Each student must have a bag for all their belongings. The bag must be big enough to hold all items your child will need throughout the day. Bags are to be brought to camp **EVERY DAY**. Please make sure your child has their name written on **ALL their belongings.**

Sneakers - Students must wear proper shoes or sneakers. None of our outdoor activities are able to be done in flip flops they will not be able to participate in the day's activities. **NO FLIP FLOPS.** Even when we go swimming we engage in free park and playground play.

Bathing Suits - Please, have your child bring their bathing suit and towel on pool days and water war days. This will insure that they have a change of clothing when they are done swimming or water battling. Students have plenty of time to change in and out of their suits when necessary. A large plastic bag to put wet clothing into is suggested. **NO FLIP FLOPS**

Uniforms - Students without a uniform will be able to participate in class if they have appropriate clothing for **ONE DAY**. If students come to class without a uniform on the **SECOND DAY** a uniform will be provided to them, at your cost (\$50.00).

Cell Phones - UMAC prohibits the use of cell phones (outside of gaming) by students at all times. We strongly discourage students bringing cell phones, however we will allow them on premises as long as they are **TURNED OFF** as soon as they enter the building. Students needing to communicate with their parents or vice versa may use the school phone to do so. If a student is found using a cell phone it will be stored in the office until parents pick them up, and they will be instructed to not use their phone again. Second offense will result in a confiscation and a ban on the cell phone being brought back on premises, the phone will be sent home with parents.

Electronic Devices - Handheld devices (i.e. PSP, Nintendo DS, and IPOD) are permitted during Summer Camp under the following conditions. These devices, any games, and cords are to be labeled with your child's name and brought to the office upon arrival to UMAC. They will be distributed at the appropriate time during the day when students are able to use them and then collected again until the end of the day. Any devices or games found out will be confiscated and returned to parents at pick up with instructions to not bring the device again

Pick Up- Students will only be released to a parent or approved people. If someone else is picking up you MUST CALL OR EMAIL THE CENTER and specify who is picking up, and what time. Please let the person picking up know that unless they are recognized they will need to show ID before we will release the camper. Please keep in mind that all of the policies are for your child's safety not your convenience please help us follow Westchester County standards and practices to keep your camper safe.
